The Contract shall be the FIDIC CONDITIONS OF CONTRACT FOR DESIGN, BUILD AND OPERATE PROJECTS (SEPTEMBER 2008), ISSUED BY THE INTERNATIONAL FEDERATION OF CONSULTING ENGINEERS, as amended.

The Contract Period shall be for a duration of seventy two (72) months (or six years) in total, including the Design-Build and Operation Service Periods, with an option, at the Employer's election, to extend the Contract Period for another twenty four (24) months.

The Design-Build (Section 1) shall start at the Commencement Date, and the Operations Service Period after twelve (12) months.

Only tenders with a B-BBEE contributor status level of 1, 2, 3 or 4, are eligible to tender.

Tenderers, or in the event of a joint venture, each member of the joint venture, shall be registered on the National Treasury Central Supplier Database at the closing date for tender submissions. Tenders received from such tenderers who do not comply with this requirement, will be declared non-responsive.

Preferences are offered to tenderers who comply with the criteria stated in the Tender Data.
