PART A:

- That the application be heard as one of urgency in terms of Rule 6(5)(12) of the Uniform Rules of Court and that the normal rules relating to form, service and periods for set-down of applications be dispensed with.
- 2. That the first, second, third, fourth and fifth respondents be interdicted from taking any further steps or issuing and/or implementing any regulations pursuant to the decisions set out in prayers 3 and 4 below, pending the finalisation of the application to review and set aside the decisions as set out in Part B hereinunder.

PART B:

- 3. That the decision by the second respondent to classify the impact of severe electricity supply constraint as a national disaster as published in Government Gazette No 48009 of 9 February 2023 be reviewed and set aside.
- 4. That the decision by the third respondent to declare a national state of disaster as published in Government Gazette No 48009 of 9 February 2023 following

the classification by the second respondent as referred to in prayer 3, be reviewed and set aside.

- 5. That the second and third respondents be ordered to pay the costs of this application jointly and severally, including the cost of two counsel.
- 6. Costs against any other respondent only in the event of opposition
- 7. Further and/or alternative relief.

TAKE NOTICE FURTHER that the accompanying affidavit of **STEFANIE FICK** together with the annexures thereto will be used in support of this application.

TAKE NOTICE FURTHER:

- a) that in terms of Rule 53(1)(a) of the Uniform Rules of Court, the respondents are called upon to show cause why the decisions referred to above should not be reviewed and set aside;
- b) that in terms of Rule 53(1)(b) of the Uniform Rules of Court, the second and third respondents are called upon to dispatch to the Registrar of the above Honourable Court, within 15 (fifteen) days after service of Notice of Motion upon it, the records of all documents and all electronic records that relate to the making of the decisions referred to above, together with such reasons as the

second and third respondents are by law required or desire to give or make, and notify the applicant that is has been done;
