BY AGREEMENT between the parties, the following order is made:

- The first to sixth applicants ("the intervenors") are granted leave to intervene 1. as the first to sixth intervenors respectively in each of the actions consolidated under case number 22722/16 ("the consolidated actions").
- The leave granted to the intervenors in paragraph 1 hereof is limited to the 2. determination of the special pleas in the consolidated actions.
- Discovery and other pre-trial processes by, or relating to, the intervenors will, 3. unless otherwise directed by the appointed case manager, as far as possible be run concurrently with discovery and other pre-trial processes in the consolidated actions and will be governed by the Rules of Court.
- The intervenors are directed to lodge within one week of the granting of this 4. order a complete copy of the pleadings in the following actions instituted by the first respondent against them with the registrar, which copies are to be kept on file in case number 22722/16:



- 4.1. case number 38834/2017 in the Magistrates Court for the district of

- 4.4. case number 11412/17 in the Magistrates Court for the district of Johannesburg West, held at Roodepoort;
- case number 4426/2018 in the Magistrates Court for the district of Johannesburg North, held at Randburg; and
- 4.6. case number 9955/17 in the Magistrates Court for the district of Johannesburg West, held at Roodepoort.
- The proceedings referred to in paragraphs 4.1 to 4.6 hereof are stayed pending the final determination of the special pleas and further pleadings consequential thereon in the consolidated actions.
