REFERRAL OF SUSPICIONS TO THE INVESTIGATING DIRECTORATE IN TERMS OF SECTION 27 OF THE NATIONAL PROSECUTING AUTHORITY ACT 32 OF 1998

- 1. Please take note that the Organisation Undoing Tax Abuse ('OUTA") hereby is reporting suspicions of criminality to the Investigating Directorate.
- Please find the sworn affidavit of Hendrik Roedolf Heyneke, in his capacity as Portfolio Manager on Transport and State Capture attached hereto, wherein a comprehensive and detailed statement is made with allegations of criminality with regards to Mosebenzi Joseph Zwane.
- 3. We suspect that Mosebenzi Joseph Zwane made himself guilty of corruption, extortion, fraud and high treason. The details of the suspect can be found in the affidavit of Mr Heyneke.
- 4. A list of details of possible witnesses is attached hereto for your attention and ease of reference as Annexure "A".
- 5. The submission is in the form of an affidavit and annexures to the affidavit that is provided to you in hard copy as well as in electronic format.
- 6. There are other referrals based on the same facts that we are aware of. A complaint was laid in 2017 by OUTA at SAPS Randburg CAS 482/07/2017. The case has been consolidated with a SAPS Park Road case CAS 200/07/2017. See the attached letter from Brigadier ZA Basi Acting Component Head: Serious Corruption Investigation Directorate for Priority Investigation marked as Annexure "B".
